Relief Appeal for Landslide Victims of Shimla

On the night of 19th September 2008, a major landslide shook the Shimla valley and major damage has been caused to Tibetans. About 17 shops, including two restaurants owned by the local Tibetans were completely buried under debris. Tibetan shopkeepers have taken credit from Indian Banks and other commercial sources to do this petty business for their survival. The month of October to end of December is the only peak season in the region that Tibetan shopkeepers could earn little profit as many Hindu festivals falls during these months and high inflow of tourist. The families were completely shattered due to natural disaster as these few months of seasonal business is the major source of their livelihood.



The Department of Home, Central Tibetan Administration, Dharamsala has released a total sum of Rs. 152500.00 as an immediate relief towards affected Tibetan families through Representative Office, Shimla out of total estimated lost of worth Rs. 45,00,000.00 (INR) in this incident which still a nightmare to these families.



It is not possible without strong financial support from outside to restart and reconstruct the business damaged by landslide. Hence, we would like to strongly appeal our generous Donor agencies and individual for an immediate support. We would be much appreciated and valued for your contribution towards these landslide victims and to reconstruct their petty business, so that they can help themselves to earn and payback all credit amount well in time and to bring to normalcy.



Activities carried out by Agriculture Division

- 1) Mr. Geoff Armstrong, has visited personally to Mundgod and Hunsur Tibetan settlements to evaluate the soil and water conservation project funded by Charitable Foundation through Global Development Group, Australia.
- 2) From 13-15 Aug 08 Mr. Ngodup Dorjee, acting Secretary visited Mundgod Settlement for the Guidance & workshop on Importance of Organic Farming and its benefits in the long run, advantages & disadvantages of Chemical & Organic farming to the farmers.
- 3) From 16-18 Aug 08, Mr. Deo Dutt Singh, Consultant of USAID visited Mundgod settlement to study the feasibility of organic farming in the Tibetan settlement. Mr. Singh personally visited field level at Camp no. 8 and much impressed with organic farming activities carried by the farmers.

Rabyeling Settlement, Hunsur: - Due to the crop destruction by wild elephants in Hunsur settlement, most of the farmers has left their land uncultivated. In order to bring the land into use, Belgium project has introduced castor oil cultivation at the elephant prone area. The castor is a non-grazing plant, however the elephant destruction problem has not seized.

Lugsam Settlement, Bylakuppe: - In Purang organic camp, Black pepper plantation has been provided to grow along with Silver oak tree.

Delar Settlement, Bylakuppe: - Fruit and non-fruit trees have been distributed to all farmers, school, and monasteries during HH the Dalai Lama's Birthday. They have procured varieties plants from Mysore and distributed

Waste Management Workshop: -

Waste Management is nothing but taking care of discarded waste and garbage of institutions, organization and individual households. Seeing the detrimental effects of burning of waste and garbage; and possible occupation of space by the discarded waste and garbage in the surrounding of all the living beings, many laureates including His Holiness the Dalai Lama and numbers of experts have persistently talked publicly and advised of the importance and urgent need of the waste management, so that the coming generations may not face the consequences of faults and ignorance of the present generation.



Thus the Department of Home has taken a step forward to take up the matter and with the funding help of Swedish Organization For Individual Relief - Individuell Maniskohjalp in Sweden and India (SOIR-IM) started the Waste Management Program called "Tibetan Program 2006 - 2008" in 5 southern Tibetan settlements; Dekyi Larso and Lugsung Samdupling, Bylakuppe; Rapgyaling, Hunsur; Dhondenling, Kollegal, Doeguling, Mundgod and Dharamsala under the management of Tibetan Welfare Office, Dharamsala from June 2006. Till date the project has been going smoothly in all the 5 Tibetan settlements and Dharamsala. As of now the project has seen immense changes in the sanitation and health conscious of the settlement and the system has rooted and is receiving astronomical response from the settlement people.



Therefore, as aimed and objected by the funding organization and the Department of Home to make the project successful and sustainable after few years of outside funding and help, all the concerned authorities and staff members are putting whole hearted effort to achieve the aim and objective of individual and organizational as well.

Update Report on Mathura Fire Incident:

Last year, on 15th November, Tibetan Refugee sweater sellers of Mathura met with an unprecedented fire accident, leaving everything to ashes and shattering the lives of 42 families, who's livelihood totally depends on winter seasonal sweater selling business. The total estimated lost of goods they had suffered is Rs. 120,82,500.00.

Soon after the news of such accident reached to CTRC, has released a grant amount of Rs. 399,000.00 (Rs.9500 each to 42 families) and along with appealed to our generous donors for the donations. But fortunately we received donations through following donor agencies:

Besides above donations, Tibetan sweater sellers, Mathura have received donations from various other individuals and organizations within India. The total estimate amount of donations they received as per our record shows Rs 48,90,789.84, which is a quarter to their total amount of lost. Their elected group leaders will distribute the total amount of donations to 42 families.

This year, from the month of November, Tibetan sweater sellers, Mathura braving through the hardship, they are going to do their petty business with the support and donations received. We wish them all the success.

We also would like to extend our heartfelt gratitude to all the concern donors for their contribution. Still we need your continuous support and would like to request for any form of help from you and your organisation to those victims in the years to come.

An Appeal for Natural Calamities Relief Fund

With the generous assistance from the Government of India, the United nations High Commissioner for Refugees, many organisations and individual donors Tibetan refugees were rehabilitated by establishing around 56 Tibetan settlements in India, Nepal and Bhutan. These settlements are mostly located in remote and far away from the reach of outer world. The primary livelihood of most of these settlers depend purely on agriculture and sweater selling business in the roadside of Indian cities during winter season becomes the secondary income for survival since last more than 3 decades.

The success and good productivity of agriculture depend purely on the rainfall and favorable climatic condition in the areas. Agriculture farming mainly focuses for self-consumption and cash crop. But due to unfavourable condition of whether during cultivation, unfortunately farmers are sometime felt victims of draught, heavy downpour, landslide and wild animals which causes heavy damage to the fields and lost of year long labour and investment cost.

On the other hand, Tibetan refugees are taking cash loans from Indian banks, goods on credit from manufacturer, and other commercial sources on high interest rate to do sweater selling business at the roadside of Indian cities and towns. This short term business is the only way to earn little profit to compensate their deficit budget of the family in a year and creating job opportunity to unemployed youth. But unfortunately sometimes damages caused by natural calamities like fire accidents, theft and lost of goods on transportation etc. which face tremendous hardship to reconstruct the lost business of huge capital invested.

Hence, His Holiness the Dalai Lama's Central Tibetan Relief Committee, Dharamsala with certain aims and objectives would like to create a separate accounts and keep certain amount of FUNDS focusing on to provide emergency relief or compensate financially to those victims due to natural calamities so that victims could restart their business well in time and for that reason we are strongly appeal to our generous donors for the contribution. We would be much appreciated for your kind helping hand to meet our objectives.

Organic Farming at Phuntsokling Tibetan Settlement, Orissa

CTRC is undertaking various methods to divert the present nature of farming into Organic farming by making Organic Model Village in each agricultural based Tibetan Settlements in India. Farmers of Phuntsokling Tibetan Settlement are also a huge consumption of Chemical fertiliser since more than 4 decades towards cultivation of maize which is the only cash crop and also a monocropping in the area which cause to degradation of soil fertility and affect in declining of productivity even after usage of huge chemical fertiliser. Hence, CTRC has finalised to convert Camp No. 4 and farmers of Camp no. 2 as Model Village of Phuntsokling Tibetan Settlement, Orissa as per the interest shown by farmer since 2007 by injecting Rs. 19,27,821 so far from the total budget allocation of Rs. 34,69,728 to carry out activities and objectives set out to achieve within two years programme. The programme is funded by Belgium Foreign Ministry.

Following activities were acried out as 1st year program through Settlement Office: -

- 1) Conducted baseline survey and soil analysis test on 210 acres of land during the month of Jan. 2008 and the report shows that soils for the Organic Model Village were moderated to acidic. To check or rejuvenate the acidic soil, the lime stone powder or paper mill sludge were recommende by the soil chemist.
- 2) Organised training & exposure trip to Gujarat from 4th - 10th March 2008 to create awareness and to adoption of new method of cultivation.
- 3) Under Soil nutrition management, 36 farmers of camp no. 4 were distributed 47,00 kgs of vermi compost, 616 tractor trailers and 69 truckloads of farm manure and 10 tractor trailers of tank silt to increase the soil nutrition.
- 4) Following several new varieties of Local Organic Seeds were procured from outisde and distributed to farmers for cultivation during 1 year's project period:
 - a) Paddy (balck husk) 585 kg
 - b) Soghum (Jowar) 60 kg
 - c) Pearl Millet (Bajra) 39 kg
 - d) Maize (Kollegal) 55 kg
 - e) Grren gram (201 kg)
 - f) Paddy (hathi) 985 kg
 - g) Finger Millet (Ragi) 706 kg
 - h) Groundnut 300 kg
- 5) Bio-pesticide preparation and treatment skills were provided by AEO of Kolegal along with distribution of 4 mixer, 2 grinders, 12 sprayer and 36 containers of 80 litres capacity to farmers of Camp no. 4
- 6) Organic Urea/Cow Urea Pits: The project has provided 2 numbers of concrete pits for cow urine collection to Mr. Sangye, H/27 by aiming to collect cow urine, so that he can use with different components for making organic pesticides and manures.
- 7) Importance of keeping farmers dairy: They have made farmers dairy for each family as record book of organic farming and for future references.

More and more farmers are showing keen interest and started to learn that long term effect from conventional farming and diverting their nature of farming by adopting multi-cropping system to rejuvenate the soil nutrines by using various organic compost.
