**Call for Urgent Support**

As you are aware of the unprecedented shocking fire disaster that occurred recently at Tibetan Sweater seller warehouse which was located in Dhule, Maharashtra. On the mid-night of 31st, August.2019, the fire broke out due to electric shock at their location, it's caused 12 Tibetans refugee families who kept winter garments in warehouse were totally burnt and their garments are razed to ashes. Due to fire mishap occurred and it caused huge loss of INR: 265, 19,661 which is very difficult for them to recover the loss. It has left them both financially and emotionally traumatized. According to the report we have received from the concerned Tibetan Settlement officer following the incident and after the incident Home Kalon met with the fire victims. The representatives of sweater sellers presented their grievances and informed about their losses. After all, they have suffered a huge loss in financial terms due to total loss of their merchandise to fire. This incident has virtually deprived them of their lifetime's saving. Moreover, they have to repay the loan hired from the wholesalers and they are totally helpless.

I therefore, urgently request you to kindly donate funds so that our people who have fallen victim to this unfortunate and tragic incident could be reasonably supported to start a modest livelihood for their family.
